In mid-June 2006 *quantum* became more of an issue. The violations of human rights conventions hadn't diminished; in fact they got worse to the point coalition partners adjudged me entitled to an injunctive order that would assess damages exponentially until the perps would stop or had become technically insolvent. The triggering event was recorded as follows (as documented in Chapter 1):

### **Drawing Blood: Proving Yet Again How Human Experimentation Advances Can be Employed to Further Objectives of the Chinese Military and the Leaders of the Last Democratic Fiefdom: Revisited**

Canada's sociopaths did it again. Eating his meal watching game seven of the Stanley Cup broadcast from Carolina on June 19, 2006, just minutes after the Edmonton Oilers scored its first goal, the *Article 7* technicians got all schadenfreude giddy and used a hypnotic trigger to make the Canadian lawyer bite his tongue, causing a bleed and a lesion.

This latest hypnotically induced involuntary muscle movement didn't just nick his tongue. The gash, a quarter inch left of center left a piece of tongue hanging. That means there was a significant manipulation of the jaw and tongue muscles to achieve this latest battery.

While the bleeding subsided quickly, the discomfort of the lesion remained; and will likely do so for a day or so.

There being agreement that more damages ought to be forthcoming for ongoing unlawfulness, an evidence diary was commenced and faithfully kept.<sup>1</sup>

### **The Daily Torture Diary: Documenting Violations in the Last Democratic Fiefdom**

On Tuesday, June 20, 2006, the Canadian lawyer authored *Assessing More Compensatory, Aggravated, Exemplary and Punitive Quantum Against the Last Democratic Fiefdom*. Since damages to be assessed against the Chinada elite on a daily basis are going to be significant, it

is procedurally important to document the violations for the diplomatic record.

Added damages were assessed in a manner that is analogous to a daily fine regiment levied as a result of violating court injunctions. Because of the egregious, lengthy and persistent nature of the abuses, and which were part of a campaign of unlawfulness dating back to the late 1980s, the fine double each week the violations persisted. Much to the astonishment of coalition partners, the experimentation and torture continued. The malfeasant were clearly saying to the partnership they were going to proceed with stealth cognition technology development and torturing me no matter what. And in their psychopathological arrogance they were calling the coalition's bluff it wouldn't seize assets.

It's to be recalled that the NATO Alliance defeated the Soviet Union principally by bankrupting its economy through President Reagan's accelerated arms race. Since it takes money to fund imperialistic aggression, the coalition decided to do the same to those leading this new global hegemony bid. In addition to providing the Canadian lawyer the justice he was deprived of because of a biased court system, the asset seizure route is also taken in part to begin the process of neutralizing the threat posed by the China-Canada military alliance.

This chart demonstrates how the fine was calculated. The original daily amount set by the coalition was significant; but for the purposes of illustration the starting assessment is one cent.

There is nothing unorthodox or controversial in the assessment. It follows the same juristic methodologies employed by courts everywhere in the civilized world when their injunctive orders are blatantly and enthusiastically ignored. The torturing malfeasant could have halted their violations of domestic and international law at any time; but chose not to do so.

Was it ever believed I'd collect everything assessed against malfeasant parties? Of course not. The purpose of this exercise was to prove beyond any doubt how committed MK-Ultra R&D principals were and how much they felt invincible, insulated and immune in perpetuity.

President Bush's ratification commitment consisted of appearing in the back-channel either by way of a scheduled public event or *ad hoc* breaking into the broadcasts of CNBC or CNN each and every Monday for three straight months. Below is a chart prepared in late August 2006 both for the diplomatic evidence record and to drive home to Canada's rich, powerful and Chinese how serious coalition partners were about these damages and that they were going to be eventually collected:

**What Do the All the Mondays During the Summer & Autumn of 2006 Have in Common That Should Generate Palpable, Unmitigated and Inescapable Fear in Last Democratic Fiefdom?**

President Bush held press conferences and other public appearances early on every Monday – the day on which *quantum* doubled - for three straight months. This was intentional and meant as an undeniable ratification of the *quantum* increase schedule and the doubling of the daily punitive damage award. This chart identifies the Monday and the title of the archive entry documenting what occurred.

In August, evidence collection concluded having observed no amount of damages was going to halt illegalities.

**Retiring the Torture Diary: Continuing *Quantum* Calculation But No Longer a Need to Document Violations in the Last Democratic Fiefdom**

The *Torture Diary* served a valuable function. It collected evidence on a daily basis of a continuing intent on the part of the Beijing government and Canada's elite to torture, stalk, harass, intimidate, threaten and cognitively interfere and manipulate the Canadian lawyer. It demonstrated on an on-going basis there was no intention on the part of these parties to stand down violations of either international law or domestic law and to negotiate in good faith with the international community to resolve outstanding issues.

From Monday, June 19, 2006 to Thursday, August 24, 2006, the Canadian lawyer kept a daily record of violations of international and domestic law for the diplomatic evidence record. The *Torture Diary* served as an evidence recording mechanism pursuant to the *quantum* increase schedule ratified by the coalition.
